## REPORTS OF COMMITTEES / RESOLUTIONS

#### 1. UTILITY COMMITTEE - Councillor Irene Dawson

Councillor Dawson noted the Committee met on April 14, 2015.

Councillor Dawson noted Greatario completed repairs to the I-Beams and repaired a few small leaks. The reservoir did not need to be drained to complete the work.

Councillor Dawson added with the spring melt underway there has been extra water entering the sewer system and lift stations. There have been a few high level alarms but the system has been able to keep up with the higher flow.

## 2. PLANNING BOARD COMMITTEE - Councillor Jill MacIsaac

The report was included in the package.

Councillor MacIsaac reported a resident made a presentation to Planning Board highlighting small animal home based farms. Planning Board agreed this use could benefit the Town and directed staff to review options.

Councillor MacIsaac reported the Town received an application for a 32 unit apartment building, PID 245347. It was noted Planning Board will be requesting an overall site plan for this development as well as additional information.

Councillor MacIsaac noted a Development Agreement has been signed by Murphy's Pharmacy Medical Centre and the footing permit is ready for pick up.

Councillor MacIsaac noted the Town received an application from Kenmac Energy for an additional propane storage tank at 56 W.B. MacPhail, being PID # 1026137. A Development Agreement has been drafted.

**WHEREAS** the property is within the Business Park Zone therefore requiring the Developers to enter a Development Agreement with the Town before a Development Permit can be issued.

**BE IT RESOLVED THAT** the Town enter a Development Agreement with Kenmac Energy Inc. and issue a Development Permit conditional on the Developers receiving the necessary Provincial approvals.
