FINANCE/ADMINISTRATION - Councillor Corey Frizzell

a) Reports

Councillor Frizzell noted the Income Statements were distributed and everything is on track.

b) Items for Discussion:

(i) Minor Sports Rental Fees. Councillor Frizzell brought forward a draft resolution regarding waiving the fees for minor sports teams to use Town ballfields and turf fields. Councillor Frizzell noted he had no guarantee that the minor sports groups would lower their fees to members if the facility fees were dropped, although he hoped they would. There was a lengthy discussion regarding this resolution, with

concerns surrounding fairness to all residents instead of focussing on a few select teams and/or age group. It was suggested by several Councillors to offer a subsidy to all residents who would like to participate in physical activity and perhaps this resolution could be amended and brought back at a later date. Councillor Frizzell noted he was open to amendments to the resolution, including initiating it as a pilot project, including other groups, subsidies, among other things. Councillor MacIsaac offered to second the resolution as is, but asked Councillor Frizzell if there were to be any amendments, to forward them to her prior to the Council meeting on Wednesday, January 16th, 2019.

- (ii) Councillor Frizzell noted Parks and Recreation will be looking for Corporate Sponsorship and will advise staff to reach out to see what the cost would be to hire someone for this process.
- (iii) CAO Coady stated the Town is in need of an Organizational Review. The Committee agreed, stating an RFP could go out as soon as possible to get the process started.
- (iv) CAO Coady asked the Committee how they would like to have their Council packages delivered for the monthly Council meetings. All members are to have their response to the CAO by Thursday, January 10, 2019.

PLANNING COMMITTEE - Councillor Jill MacIsaac

Manager Dean Lewis stated Planning Committee discussed the re-naming of the TransCanada Highway and asked Council to come up with suggestions and send them to him by Friday, January 11, 2019. It was noted this would also be going to Eliot River School for the students to come up with their suggestions as well.
