i) FINANCE/ADMINISTRATION DEPARTMENT – Councillor Corey Frizzell

a) The comparative income statements were included in the package. Councillor Frizzell would like to see separate lines for Terry Fox Complex expenses on the income statement and was advised that staff would look into the possibility of further breakdown. A budget public input session will be held in February. b) Resolution:

FA-01-2020 Blue Community

Moved by Councillor Corey Frizzell Seconded by Councillor Elaine Barnes

Whereas: Almost 2 billion people around the world do not have access to clean drinking water, 4 billion people face severe water scarcity and 2.5 billion people do not have adequate sanitation,

And Whereas: On July 28, 2010 the United Nations General Assembly passed a resolution recognizing human rights to water and sanitation,

And Whereas: Recognizing these rights to water and sanitation is one of three steps, in addition to banning bottled water in municipal facilities and at municipal events and the promotion of public water and wastewater infrastructure, needed to declare the Town of Cornwall a "Blue Community",

Therefore, Be it Resolved: That the Town of Cornwall recognizes and affirms that water and sanitation services are fundamental human rights,

And Be it Further Resolved: That the Town of Cornwall will make every reasonable effort to find a solution in cases of non-payment before shutting off water and wastewater services in any residence for non-payment of the water and wastewater services,

And Be it Further Resolved: That where access to municipal potable water is available, single use bottled water will not be sold in municipal facilities, from municipally owned or municipally administered concessions, or from vending machines in municipal facilities, and that single use bottled water will not be provided at municipal meetings or events where access to municipal water is available,

And Be it Further Resolved: That the Town of Cornwall oppose privatization in any form of water and wastewater treatment infrastructure and services and commits to keep these services publicly financed, owned, operated and managed,

And Be it Further Resolved: That the Town of Cornwall lobby the federal government to fulfill its responsibility to support municipal infrastructure by investing in a national water and

wastewater infrastructure fund, that would fund only public projects, to address the growing need to renew existing water and wastewater infrastructure and to build new systems,

And Be it Further Resolved: That the Town of Cornwall forward this resolution to the Federation of Canadian Municipalities for circulation to its members and the federal government.

PR-01-2020 Ballfield Lighting

Moved by Councillor Corey Frizzell Seconded by Councillor Elaine Barnes

Whereas: The Town of Cornwall issued a tender for the lighting of the upper ballfield at the Terry Fox Sports Centre,

And Whereas: Several bids were received in response to this call for tenders with all proposals substantially over the budgeted amount for the project,

And Whereas: The Town, through its engineers, in order to bring the project in on budget removed certain items from the specifications for the project and invited the low bidder to submit a revised price for the project, and the low bidder submitted a revised price which was still over the original budget,

And Whereas: The Town retendered the project with the scaled down specifications and several responses were received, which were again in excess of the budgeted funds, and the Town, through its engineers, entered into negotiations with the lowest bidder which resulted in

additional cost savings,

Therefore, be it Resolved: That the Town of Cornwall, per the recommendation of the Town's engineers, award the Ballfield Lighting project to Hansen Electric in the amount of \$458,850 inclusive of HST.
